#### **Proclamation No.185/2019**

# Definition of Powers and Duties of the Executive Organs of the Somali Regional State proclamation

WHEREAS, the Reorganization of Executive Organs of the Somali regional State is essential for the success, sustainability and institutionalization of the, Execution of good governance and reform underway in Ethiopia and within the Regional state;

**WHEREAS**, it has been found necessary to establish an organizational setup that can react the tangible needs of the peoples and implement the development programs of the Regional state;

**NOW, THEREFORE**, in accordance with Article 49 (3) (A) of the Revised Constitution of the Somali Regional State, the state council hereby proclaimed as follows

#### **PART ONE**

#### **GENERAL**

#### 1. Short Title

This Proclamation may be cited as the "Definition of Powers and Duties of the Executive Organs of the Somali Regional State Proclamation No. 185/2019 "

#### 2. Definition

In this Proclamation, unless the context otherwise requires:

- 1. "Constitution" means the revised Constitution of the Somali Regional State.
- 2. "Regional State" means the Somali Regional State.
- 3. "other Executive Organs" " means bureaus, offices Commissions, Agencies, Authority, Institutions, or any other state Organizations having legal and professional independence accountable to the Executive Bureaus established under this proclamation;
- 4. Any expression in the masculine gender includes the feminine.

# **PART TWO**

# **Establishment of The Executive Organs of The Regional State**

## 3. Establishment of members of the State Cabinet Council

Members of the State Cabinet Council as established pursuant to Article 58 (1) of The Constitution is an organ composed of the following members:

- 1. The President of the Regional State;
- 2. The Vice-President of the Regional State;
- 1. Heads of Executive Bureaus specified under Article 4 of this Proclamation; and
- 2. other Officials to be designated by the Chief Executive
- 3. Other bodies which are established by law as member of State Cabinet Council.

#### 4. Establishment of members of state cabinet council

The following Executive bodies are established by this Proclamation as members of state cabinet council:

- 1. The Office of chief executive;
- 2. the bureau of Agriculture and natural resource;
- 3. Livestock Resource and Pastoral Development Bureau
- 4. Urban Development and Construction Bureau;
- 5. The Education Bureau:
- 6. Health Bureau;
- 7. The Bureau of Finance:
- 8. Civil Service And Human Resource Development Bureau
- 9. The Bureau of roads and Transport;
- 10. the Security affairs Bureau
- 11. The Attorney General;
- 12. The Bureau of Water
- 13. The Bureau of Education, technical, vocational and Science;
- 14. The Bureau of Labor and Social Affairs;
- 15. The Bureau of Women, and Children affairs;

- 16. The Bureau of Culture and Tourism;
- 17. the Disaster Risk Management bureau
- 18. The Bureau of Trade and Industry;
- 19. The Bureau of Revenues.
- 20. bureau of investment and diaspora affairs
- 21. bureau of sports and Youth affairs;
- 22. bureau of communication;
- 23. The Bureau of Petroleum, Mines and an energy;
- 24. bureau of environmental protection, forestry and climate change;
- 25. Irrigation and Basin Development Bureau;
- 26. The Bureau of Innovation and Technology;

## Article 5. Powers and Duties of the state cabinet Council

The powers and duties of the state cabinet Council of Somali regional state are those defined under Article 59 of the Constitution and under other laws.

## Article 6. Powers and Duties of the Chief Executive

The powers and duties of the Chief Executive are those defined under Article 61 of the Constitution.

# **Article 7. Powers and Duties of the Deputy Chief Executive**

The powers and duties of the Deputy Chief Executive are those defined under Article 62 of the Constitution.

# **Article 8. Meeting Procedure of the state cabinet Council**

- 1. the state cabinet Council conducts ordinary and extraordinary meetings in accordance with its procedural rules:
- 2. The Chief Executive presides over the meetings of the Council; however, in the absence of the Chief Executive, the Deputy the Chief Executive shall preside over the meetings of the Council.

# Article 9. Organizational setup of bureaus

Each executive bureau shall have the following Organizational setup:-

- 1. Bureau head upon the nomination of the Chief Executive to be approved by the state council.
- 2. deputy bureau head or deputies appointed by the Chief Executive;
- 3. core processes and other necessary staffs;

# Article 10. Common Powers and Duties of members of the cabinet Council

- 1. Each member of the Council shall have the member of the of the Council has a common and an individual responsibility to execute the decisions passed by the cabinet council;
- 2. members of the Council shall have the responsibility to keep the meeting time table, code of conduct and keep the confidentiality of all matters brought before the council, particulars shall be specified by law

# **Article 11 Accountability of other Government Organs**

- 1. The following executive organs shall be accountable to the office of the chief executive:
  - A. Grievance handling commission.
  - B. Somali and oromia Regions Bilateral development coordination office
  - C. Research and policy study commission.
- 2. The following executive organs shall be accountable to the agriculture and natural resources

  Bureau
  - A. Cooperative Agency
  - B. Pastoral nd Agro-Pastoral Research Institute
- 3. The following executive organs shall be accountable to the Security affairs Bureau:-
  - A. police commission
  - B. Special force.
  - C. vital events registration agency
- 4. The following executive organs shall be accountable to the Health Bureau:-
  - A. HIV/AIDS prevention and control office
  - B. Food, Medicine, and Health Care Administration and Control Authority
- 5. The following executive organs shall be accountable to the Attorney General:-

- A. the Prisons Administration
- B. Organs of Justice Professionals Training Center
- 6. The following executive organs shall be accountable to the Bureau of technical and vocational Education and Science:-
  - A. Center for professional Competence Agency
  - B. technical and vocational Education and Science colleges
- 7. The following executive organs shall be accountable to the Civil Service and Human Resource Development Bureau:-
  - A. Managerial Public Service College
- 8. The following executive organs shall be accountable to the Urban Development and Construction Bureau;
  - A. Urban Job Opportunities Creation and Food Security Agency
  - B. Agency for the administration of Housing development
- 9. The following executive organs shall be accountable to the Bureau of Finance;
  - A. the Public Procurement and Property Administration Agency
  - B. the Public Enterprises Holding and Administration Agency

# Article 12: The scope of accountability of other Government Organs

- 1. The scope of accountability and working relationship of other Government Organs established under Article 11 of this proclamation shall be determined by law.
- 2. The powers and duties of organs specified under sub-Article (1) C, (3) B and c, (5) A and B, (8) A and B, and (9) A and B of Article 11 of this proclamation shall be determined by law.
- 3. Without prejudice to the matters provided under the provisions of sub-articles 2 of this Article, Authority, commissions, colleges and offices specified article 11 of this proclamation with regard to accountability, shall continue their function in accordance with the legislations establishing them.

#### Part Three

## **Powers and Duties of Executive Bureaus**

## Article 13 Powers and Duties of the office of the chief executive

Without prejudice to the existing provisions of other laws, the Office of the president shall have the following Powers and Duties to:-

- 1. Provide General and administrative support to the President and the Regional Administrative Council. also ensure that the necessary manpower and material for their mandate are Equipped and provided with;
- 2. execute and direct duties related to the cabinet affairs:
- 3. Give the appropriate protocol services to the President, Vice president and other Regional government officials.
- 4. ensure and organize that the conference hall for ordinary and extra ordinary sessions of the executive council has been properly arranged, and accomplishes the materials and other matters required by members of the council for work are found complete; provide the appropriate protocol services.
- 5. Ensure and follow-up the implementation of laws enacted by and resolutions passed by the state council and federal government in the regional state.
- 6. cause the minutes and other documents of the executive council are timely prepared, signed and upon conformation properly kept;
- 7. Submit decisions and instructions decided by the Regional Administrative Council to the concerned organs for implementation or cause its implementation;
- 8. Give decisions on applications and complains of the society that requires Administrative solution submit to the office which it can solve or where matter couldn't be solved by the office, submit the matter together with its recommendation to the organ that the complaints are submitted against or the head of the concerned government organ;
- 9. Establish a transparent and fair system that governs complaints handling procedure and submission of public complains; create different mechanisms and ways of communicating with this system.
- 10. Undertake study based on the type, complexity and causes of complaints that the community seeking administrative remedy, and present the findings of the study with its recommendations to the President.

- 11. coordinate and organize relations of the regional state with federal government, neighboring states and other corresponding Region's, also follow up the activities of development cooperation between bureaus and different institutions and other international cities;
- 12. provide library, research, information and documentation services to the members of the cabinet and divisions of the administration of office;
- 13. receive and welcomes on behalf of the Executive Council federal and international honorable guests visiting to the State;
- 14. so as to build the good image of the region and Create conducive environment for public participation in connection with development and good government programs, organize and co-ordinate the timely undertaking public symposiums and consultative forums and other public conferences,
- 15. Facilitates the work relationship with the president of executive organs accountable to the president;
- 16. leads the supportive supervision activities towards works of lower administrative hierarchies of the state government;
- 17. Perform other activities entrusted by the President.
- 18. own and possess property, enter into contracts, sue or be sued in its own name;

# Article 14:- Powers and Duties of Bureau of Agriculture and Natural Resource

Without prejudice to the provisions of other laws, the Regional Bureau of Agriculture and Natural Resource shall have the following powers and duties:

- Based on national Agricultural and Natural Resource development laws, policies and strategies, design the regional state laws, policies and strategies that relates to Agricultural development, rural job creation, proper rural land Natural Resource management systems, implement upon approval.
- 2. Formulate state policies on the promotion of Agricultural production and natural Resources conservation. provide and supply different types of inputs and create marketing and market linkages for Agricultural and natural Resources productions;

- 3. Coordinate, and administer Agency that are accountable to the Bureau by assessing their worka programs and budget and submit to the Cabinet for approval, upon approval ensure the proper execution of the work programs.
- 4. Promote the expansion of effective agricultural conservation, improved crops and natural Resources and ensure the provision of extension service, awareness creation and investment and technical support to the farmers, and pastoralist community engaged in the agricultural sector for enabling them to improved livehood through poverity redection schems.
- 5. Administer, mobilize and coordinate programs and projects aimed to achieve sustainability of food security in rural areas.
- 6. Establishes, directs and promotes agricultural and natural resource research centers, FTC training centers, and soil and crop laboratories. It also trains and mobilizes agricultural and natural resource professionals.
- 7. In Collaboration with stakeholders, ensures that farmers engaged in agricultural production receive loans and credit services that can contribute to agricultural development and natural resources.
- 8. It studies ways to increase crop production and natural resources, and provides advice and support to farmers and agro-farmers on how to increase agricultural productivity.'
- 9. Provides support to private investors engaged in investing in agriculture, crops and exploitation of natural resources.
- 10. Provide comprehensive support to private investors engaged in the agricultural, crop investment and consumption sector;
- 11. Oversees and monitors the conditions that may impede agricultural development, and provides early warning and preparedness systems in collaboration with government and non-government agencies.'
- 12. Establish a system to control and prevent the outbreak of crops diseases, migratory pests and weeds;

- 13. Cause, follow up and create the appropriate conditions that the agricultural production be bear to maintains the products used as food in the regional state and in the country;
- 14. Ensures that the development packages for the advancement of women and youth farmers are in line with the Local Women's and Youth Development Policy.
- 15. Avail agricultural Extension service packages adaptable with the irrigation lands and rain feed areas. As well ensure, Follow up and supervise that any fertilizers and crop production inputs supplied to the market maintains its quality standard;
- 16. Initiate and prepare policies and programs on job creation in the rural settings to alleviate the live hood of pastoralists and agro-pastoralists.
- 17. To achieve efficient Agricultural Extension Programs in the Region, Build and support the woredas capacity that enables to provide training in various profession of technology.
- 18. Construct marketing centers and warehouse for the deposit of agricultural productions and provide technical support to farmers on availability and provisions of marketing facility and marketing information.
- 19. Ensures monitoring and follow-up species of plants, seeds and forage for the team and out of income distribution.
- 20. Encourages investment in agricultural production and natural resources and grants rural land use licenses to members who invest in rural areas.
- 21. Registers licenses and monitors individuals, cooperatives and companies involved in the exploitation and use of rural land.
- 22. Ensures that Parties are empowered by law to use rural and public land, the rural community, individuals and organizations to implement the declarations, laws and regulations on the environment, use and management of rural land.
- 23. In collaboration with the stakeholders, studies causes of farmers displacement from their land. Ensures that compensation or other land is transferred.
- 24. Register, Administer, follow up and supervise the use of land, land holding Certificates, land type and size of rural land to be certified and thereby evaluate the results of the same.

- 25. Establish nursery sites where plant seeds are to be produced so as to prevent degradation/ deforestation and soil erosion, design and implement mechanisms for the prevention of soil erosion, galleries and decrease of soil fertility.
- 26. Devote in proper utilization of incense, myrrh, various gums and medicinal plants.
- 27. Establish a mechanism and projects that helps the prevention and control of land dilapidation, flood and soil erosion, implement upon approval,
- 28. Without prejudice to the powers given under other laws to bureau of Irrigation and basin development, Carry out water-harvesting activities, traditional river diversion and irrigation development works on small-scale irrigation schemes;
- 29. Expand and provide supply to farmers and pastoral community modern agricultural technology and mechanization.

# Article 15: Powers and Duties of Livestock Resources and Rural Development Bureau

In addition to the powers conferred on the Office under other laws, the Office of Livestock Resources and Rural Development shall have the following Powers and Duties:

- 1. Based on the country's livestock development policies and strategies; prepares local livestock and nomadic development policies and strategies and, upon approval, implements them.
- 2. Prepares projects for livestock development, natural grazing, treatment and marketing of livestock, and shall, upon approval, implement them.
- 3. He shall oversee and administer the agencies under his office; Checking their work plans and budgets to the Local Government for approval, and, when approved, monitoring the implementation of the approved objectives.
- 4. Enables the broader expansion of livestock, plant and pasture services on a sustainable and cost-effective basis;
- 5. Lives and coordinates integrated programs and development projects towards the self-sufficiency of the local pastoralist community.
- 6. Participates in and promotes the provision of research and dissemination of modern animal husbandry technologies and techniques to pastoralists.

- 7. Collaborates with stakeholders and facilitates conditions for enhanced livestock trade and marketing.
- 8. In collaboration with the relevant organs, facilitate conditions of providing credit facilities to pastoralists
- 9. Provides support to private landowners involved in local fodder investment.
- 10. Monitor and monitor conditions that may impede the development of livestock and fodder and provide early warning and preparedness for animal diseases.
- 11. It will take appropriate action to prevent and control infectious diseases in animals occur, we prepare, and implement strategies enabling environment looga how to provide emergency services for immunization and treatment of animals;
- 12. In collaboration with the Office of Agriculture Ensures the establishment of parks and grazing reserves that can be used to feed livestock in times of drought.
- 13. Establishes, manages and expands the environment for veterinary research centers and the development of veterinary treatment centers.
- 14. In collaboration with the concerned parties, ensure that the pastoralist community has access to modern veterinary reproduction systems, credit services, vaccinations and veterinary treatment.
- 15. It shall develop a policy and strategy for the development of fodder in the area and shall implement it in due course;
- 16. Develop a policy and strategy that will lead to a fair and equitable system for the pastoralist community to benefit from pasture and fodder; and the time of approval shall come into force;
- 17. To set at the political level development packages for women and youth pastoralists; at the time of its adoption, implement and monitor their implementation;
- 18. It shall verify, monitor and monitor the quality and level of inputs required by the pastoralist community such as veterinary medicines, production equipment, training and breeding animals imported or vaccinated. local markets;
- 19. Works in the cultivation or propagation of modern animal dung
- 20. akes steps to prevent and control animal diseases and provides training and awareness to pastoralists.

- 21. Prepares the Environmental Fisheries Resource Development Strategy and, once approved, implements it.
- 22. Provides technical support and training to individuals, cooperatives and companies engaged in the exploitation of local fish resources...
- 23. Perform other activities that help to achieve its objectives or carry out its power and duties given by law.
- 24. own and possess property, enter into contracts, sue or be sued in its own name;

# Article 16:- Powers and Duties of Urban Development and Construction Bureau

Without prejudice to the existing provisions of other laws, the Urban Development and Construction Bureau shall have the following powers and duties to:

- 1. based on the national Urban Development and Construction policies and strategies, design state wide policies and strategies, and implement upon approval;
- 2. Ensure the observance of the standards and level of category set for it in all Construction of residential housing, urban roads and design and construction works;
- Supervise all construction works in the Regional State, carry out studies and researches
  aimed to identify the type of technologies, construction materials to be used for the
  constructions and urban development works.
- 4. Ensure that the criteria and level set for design constructions by Federal and Regional state are fully observed and enforced in the Regional state.
- 5. Cause the issuance of laws and directives relating to the design of construction activities and urban plan development; implement upon approval;
- 6. issue criteria and standards that determine the grades of engineers and architects engaged in the construction sector con; license and issue certificates of professional competence to them and supervise their works;
- 7. Register, license and revoke certificates of competence to contractors engaged in the Constructions works.
- 8. Works with federal institutions that provides basic service development and facilitate conditions to expand infrastructure projects in the Regional state;

- 9. Carry out the design and construction works, repair and supervision of construction works and cause any opportunities of contracting to private contractors and consultants enterprises. Supervise its implementation;
- 10. Carry out the Coordination and supervision of the execution of government constructions works implemented by the budget of The Regional State is in conformity with the quality standards, time and cost limits, as provided in their contract;
- 11. Provide work permit to contractors and consultants who are registered at national level and willing to participate for contractual bids as well as register, encourage and provide support housing corporations.
- 12. cause conditions that increase participation of the society on planning and execution of urban development works;
- 13. Undertakes studies and researches aimed to prompt the rapid multidimensional growth and development in urban areas.
- 14. minimize urban housing problems, undertake Study to assess the level of urban inhabitants housing difficulties, implement projects for the construction of apartment houses aimed to minimize urban housing problems.
- 15. Give training and facilitate conditions to be given for urban services provisions to strengthen their performance capacity;
- 16. Undertake studies in connection with the level of poverty of inhabitants' in urban settings of the regional state; support the implementation thereof; and ensure food security and job creation in the urban settings;
- 17. Follow up the implementation of projects underway by governmental organs and non-governmental organizations in the urban settings and ensure their conformity with the urban development necessities and strategies.
- 18. encourage urban administration to realize rapid development through cooperation, experience sharing and support among urban administration; facilitate the enabling conditions for this settings;

- 19. Establish Micro and Small Enterprises in urban settings of the region on the basis of study made towards in the sector; provide professional support that is necessary for them.
- 20. provide a cadaster systems for managing update information keeping that facilitates the acceleration urban land management and utilization activities as well as urban services provisions and follow up its implementation;
- 21. Designs a method that might able to enhance service provisions improvement system in urban settings; and follow-up the service delivery in strategic manner.
- 22. in cooperation with the urban administrations, cause the preparation of sufficient land to be set aside for various investment and public housing services, and follow up the its promotion and delivery thereof;
- 23. Undertake the preparation and implementation of urban plan; and ensure whether in the execution of construction projects and utilization of urban land might be observed; provide technical and professional support to the urban centers of the Regional State;
- 24. Examine on the growth of standardized promotion urban centers and thereby determine standard of the urban qualifies based on population size and commercial movement;
- 25. Accredit municipal centers organized in the urban areas; prescribe standards for the grading of urban centers and its boundaries;
- 26. Ensure and supervise whether urban development activities properly executed in line with urban development policy, strategy and plans;
- 27. in collaboration with other concerned organs follow up the Housing projects that are being implemented by private investment enterprises in the urban areas of the Regional state;
- 28. Cause the facilitation of conditions enabling the inhabitants of the urban centers to build dwelling houses comparable to their descent capacity and benefit therefrom;
- 29. Cause the issuance of law governing the administration and determination of house rent price of urban houses owned by the Government, implement upon its approval.

- 30. lead and direct Public Enterprise that are accountable to the Bureau and Follow up and evaluate work plan and performance of public enterprises, submit their budget to the Regional state cabinet Council; ensure the execution of the work plans upon approval,
- 31. ensure as to whether all construction projects being implemented in the urban areas of the state have benefited the manpower and youth force living in the urban areas;
- 32. supervise and oversee the implementation of Construction projects being constructed by public enterprizes accountable to the Bureau and take corrective measures.
- 33. Work for and ensure that projects undertaking in urban and rural areas have linkage in a manner beneficial to the urban and rural inhabitants;
- 34. issue directives that determines the standards of urban areas clean, attractive and green required from different categories of urbans, follow up it's implementation.
- 35. Perform other activities that help to achieve its objectives or carry out its power and duties given by law.
- 36. own and possess property, enter into contracts, sue or be sued in its own name;

# Article 17:- powers and duties of Education Bureau

Without prejudice to the existing provisions of other laws, the Regional Bureau of Education shall, pursuant to this proclamation, have the following specific powers and duties:

- 1. Prepare and implement the short, medium and Long-term strategic plans and programs of the Regional state on the basis of the country's Education Policy, follow up and evaluate same and provide support necessary thereof;
- set standards for the educational institutions at all levels in line with the countrywide standards, follow up and oversee their compliance thereof as well as take corrective measures, as may be necessary;
- 3. prepare, in line with the countrywide standards, the curricula of practical and basic adult education, kindergarten, primary, interlaminate and secondary schools and teachers' education, follow up their implementation thereof,
- 4. cause the publication and distribution of the curriculum materials in the Regional State in the competitive free market with the desired quality and thereby ensure the availability of the books for sale as well as where found necessary provide to the students materials with free of charge;

- 5. See to it that all are provided with access to quality and basic education by formulating various mechanisms and alternatives assisting to promote the educational provisions in a balanced and equitable manner;
- 6. Undertake programs educational facilities whereby basic education delivered to the pastoralist's community and other students which their conditions of live hood barred to attend educational programs provided in regular educations.
- 7. based on the public demand for education, open newer schools, cause the expansion of already built schools and cover expenses for fulfilling the necessary educational inputs and other necessities required in all education institutions in the regional state;
- 8. Cause teachers training institutions found in the region, could produce teacher that can cover the required teaching needs of the Region in terms of the quantity and quantity that comply with the standard of training requirement.
- 9. with the view to enhancing the competence of teachers, directors and supervisors, conduct needs' assessment studies, cause the delivery of pre-service as wall as continuing professional improvement trainings as per the result of such study, follow up the process, evaluate same and take corrective measures thereof:
- 10. Issue and renew license of recognition for educational institutions as well as award and renew certificate of competence for teachers and Educational leadership found at all levels in the Region;
- 11. Prepare and deliver first-cycle education leaving examinations and determine the results as well as execute in the Regional State, those examinations prepared at the national level;
- 12. Cause with the help of public and private mass media technology to reach public at grassroots in kebele and woreda level carryout statewide school mobilization for registration sudents to get education in the beginning of the school calendar year.
- 13. Collect, analyze and compile various statistical data concerning State education, transmit same for the pertinent bodies;
- 14. Install and materialize a system in which the community might, having had full participation in the planning, budgetary allocation and educational development in general and with regard to schools in particular;

- 15. cause ways of granting direct assistance to the public schools by different organizations and private bodies;
- 16. Cause that the education-centered policies and laws, of Regional State and the country in effect are interpreted into practice to different educational institutions in the Regional State.
- 17. Cause the provision of educational programmes to be supported by mass media and technology that may enhance the quality of teaching and learning process.
- 18. Ensure that the school environment are conducive for the teaching and learning process and the fulfillment of the required standards to teach at any level,
- 19. Expand and organize the schools for adult education and students with special needs and ensure that the necessary inputs for teaching and learning process are fulfilled therewith;
- 20. Seek various mechanisms of community participation in the promoting of education development and school construction through educational development fund.
- 21. cause to build a connection between non-governmental organization working in the Educational sector and follow up same;
- 22. Employee, or Authorize the deployment of teachers, Supervisors and Directors of Schools under the education of the Regional State;
- 23. set standards required for schools owned by the private sector and determine their level;
- 24. own and possess property, enter into contracts, sue or be sued in its own name;

## Article 18 Powers and Duties of the Bureau of Health

Without prejudice to the existing provisions to other laws, the Bureau of Health shall have the following Powers and Duties:-

- 1. Prepare, in line with the country's Health Policy and Strategy, the region's Health Policy and Strategy and health programs which are on basis of prevention, implement same upon approval.
- 2. Ensure the due observance of laws on health service delivery throughout the Regional State; proposes to suggestions on this sector to executive cabinet of the Regional State.

- 3. Ensure the provision of cost effective and timely Health service to all the community within Regional state by giving due consideration to the pastoral community and undertake regular supervision as to whether quality health provisions are provided;
- 4. Organize and administer the health infrastructure constructions of hospitals and health centers, and ensure that the necessary inputs and manpower are fulfilled therewith; as well as ensure that the hospitals and health centers throughout the Regional State have met with the standards set for:
- 5. Undertake the procurement of drugs and medical equipment destined for use in the health centers, and hospitals, in the Regional State and ensures the distribution and supply on time.
- 6. program and distribute to the hospitals and health centers throughout the Regional State direct support that are provided by the Federal Government and donor organizations for the implementation of different programs;
- 7. Ensure as to whether health related programs to be implemented by Non-Governmental charity organizations in the Regional state are in line with the Health Strategies of the Regional state.
- 8. Set stanadard requirement guideline for the Issuance of professional license to health facilities that might be established by private investors in the Regional State and oversee that they carry out their Operations in compliance with the operational standards.
- 9. mobilize and organize mobile health team that provides mobile health service provisions to pastoralist community and ensure whether fulfilled with necessary human power, materials and logistics; follow up the supply of health service provisions;
- 10. Forecast, the possible occurrence of public health emergency and epidemic phenomenon, undertake surveillance, exploratory studies and preparatory works, provide with a rapid response as deems necessary and conduct rehabilitative activities thereof;

- 11. Appoints zonal health office coordinators, health centers managers, hospital managers and members of Administrative Board, also assigns health professionals to be deployed in the different health institutions.
- 12. In collaboration with the pertinent bodies, administer competence assurance examinations and certificates for those health professionals who shall have graduated from the public and private health colleges residing in the Regional State, effect professional registration, issue and renew license thereof;
- 13. provide the required supports to health colleges residing in the Regional to produce the necessary manpower and competence health professionals,
- 14. Provide professional, training and equipment support to woredas and city administrations in order to provide balanced health services and ensure that health facilities are cohesive and collaborative.
- 15. In order to meet the shortage of doctors, nurses and other professionals in the area, it may enter into agreements with local and national higher education institutions.
- 16. Collects and analyses information related to local communicable infectious diseases and shares this information with stakeholders.
- 17. Provides necessary support to Clinics, Health Centres and Local Hospitals to strengthen the immune system of malnutrition, poor hygiene and sanitation
- 18. provide the necessary support for the expansion of vaccination of pregnant and child bearing women and children in the Regional state and followup the outcome and level of coverage of the provision;
- 19. Provides the necessary support to expand the health service delivery plan to the environment.
- 20. Provides family/community planning services and health services to postnatal and prenatal services;
- 21. Provides anti-malarial work in malaria-prone areas, in which the community participates and provides the public with the necessary medicines and equipment.

- 22. Perform other activities that help to achieve its objectives or carry out its power and duties given by law.
- 23. own and possess property, enter into contracts, sue or be sued in its own name;

## **Article 19:- Powers and Duties of the Finance Bureau**

Without prejudice to the existing provisions of other laws, the Bureau of Finance shall have the following Powers and Duties to:-

- 1. initiate the execution of fiscal and Tax policies as well as mid-term expenditure and fiscal frame work of the Regional state;
- administer, negotiate and sign aid and loan agreements and other development programs supported to the Regional state;
- 3. prepare and follow up the implementation of long, medium and short -term plans to be 'executed by the Regional state;
- 4. provide a support relating on the budgeting, accounting, and financial management to woredas Administrations;
- 5. Coordinate the activities of the activities of non-Governmental organizations with respect to the implementation of the development projects and population policy and work in integration therewith.
- 6. Design and prepare the Budget appropriation formula that is based on fairness and equity, and submit to the concerned organ for approval;
- 7. ensure and evaluate development plans and projects on the basis of the women's and neglected groups of the society in the Region;
- 8. undertake studies towards the budget proposals prepared and submitted to it by the Regional Bureaus, Authorities, colleges, institutes, commissions, Boarding schools, Zonal, woredas and City Administrations, gather data enabling it to prepare the consolidated annual budget of the Regional State in an equitable manner, submit the draft budget to the Regional State, Budget and finance standing committees of the state council along with its recommendations for approval;
- 9. Having examined the recurrent and capital budget proposals prepared and submitted to it

- by the Regional Government bodies, gather data enabling it to prepare the consolidated annual budget of the Regional State in an equitable manner, submit the draft budget to the Regional State along with its recommendations and administer same upon approval;
- 10. coordinate, organize follow up and oversee the loan and donation resources received from non-Governmental Organizations and thereby cause to be implemented in a manner consistent and in conformity with the development plans of the Regional Government;
- 11. follow-up and ensure that public bodies and governmental organization are administering and executing the Budget in accordance with the Finance administration laws and policies of the Regional Government;
- 12. If supplementary revenue is generated, will communicate to the concerned organs and prepares plans to be executed with the supplementary revenue, then prepare the supplementary budget proclamation, recommend to the State cabinet council and state council for approval.
- 13. execute and implement Finance Administration reform programs;
- 14. be the depository of and administer the Regional Government's shares, negotiable and non-negotiable instruments and other similar financial assets;
- 15. Provide trainings aimed to building the capacities of employees and officials at different hierarchies of Regional government in the administration system of public finance and property administration, regularly follow the training needs;
- 16. Carry out the procurement of goods and services given by law on behalf of Regional Government bureaus and organs at different administrative hierarchies;
- 17. Establish an advanced budgetary and accounting system of the Regional State and supervise over its implementation on the part of the Regional Government bodies;
- 18. Prepare periodic statements of a comprehensive nature indicating the fiscal undertaking and financial position of the Regional State;
- 19. oversee and Evaluate the fiscal undertaking and execution of the development projects;
- 20. follow-up and oversee that the fiscal undertaking and public property administration activities of public bodies are in accordance with the pertinent national and Regional

- rules and regulations;
- 21. prepare and issue directives governing the procurement system and public property administration;
- 22. Prepare the long term development plan to be executed by the Regional Government on the basis of the country's development strategies and follow up its implementation upon approval;
- 23. Collect and compile the region wide data regarding natural resource, Agriculture, Industry, products, services, population and the like as well as distribute same to the concerned;
- 24. Cause the undertaking of surveying, mapping and Geographical studies towards the settlement Patterns, Agriculture, livestock, Basin and land arrangement Patterns, and ensure that this data's ought to be a baseline for the development programs and projects;
- 25. prepare socio-economic studies in the Region and cause the execution of the recommended conclusion of the study;
- 26. Analyses, monitors and ensures that the performance of the environmental development standards is responsive to the real economic situation of the Environment.
- 27. Conduct assessment of growth factors and the increase matrix of the ecnomic growth in the Regional State;
- 28. Provide training and awareness creation relating building the planning and economic management capacity government organs at various administrative hierarchies.
- 29. Issues result based developmental plans guidelines, documents and manuals for the various government hierarchies.
- 30. Facilitate, build and develop based on the results supervision and monitoring system in government institutions at various government hierarchies;
- 31. Annual indicator-based monitoring & evaluation; produces lessons learned and the challenges they regularly face as a result of achieving the goals of the annual plan, and reports to those concerned.
- 32. Implements the data analysis process to collect the environmental and statistical data

- required for local planning activities.
- 33. issue directives and manuals necessary for the implementation of the population policy of the Regional State;
- 34. work on the implementation, in the Regional State, of the population policy, carry out studies and researches, cause same to be undertaken by others and render support thereof;
- 35. prepare studies and research on the annual population growth matrix and formulation of annual development plans;
- 36. undertake studies to identify the status and conditions of service of infrastructure development in the Region, and ensure that studies proposals are executed;
- 37. design strategies to follow up and regulate that the preparation of development programs and projects by Regional Government organs give due considerations to the issues of women and peoples with special need;
- 38. Perform other activities that help to achieve its objectives or carry out its power and duties given by law.
- 39. own and possess property, enter into contracts, sue or be sued in its own name;

# Article 20:- Powers and Duties of Bureau of Public Service and Human Resource Development

Without prejudice to the powers and duties given under existing o provisions of other laws, the Bureau of Public Service and Human Resource Development shall have:

- 1. Undertake studies for the implementation of service delivery standard in government offices; based on the human resource need for execution of public works, propose the findings of the study to the executive council of implement same upon approval.
- 2. Manages monitors and ensures compliance with applicable law on the allocation of staff and matters related to salaries, allowances and overnight stays.

- 3. With a view to make a study loop-holes in the structure, systems and work force employed in different levels of management, and sets outs the future needed strategies bring sustainable change, is adopted and implemented, it will monitor;
- 4. To strengthen the persuasion of the administrative system provides technical, technical and training support to the management structure at all levels.
- 5. It proposes, studies wrong reasons good management problems, and possible conditions for the IT environment that regularly needed implementation of management systems and habits; and submits the results of the study to the Executive Council and, once approved, implements them.
- 6. Referring to the policies and strategies of capacity building and human resource development in the country prepares the policies and strategies for the capacity building and development of the local workforce and, upon approval, shall implement them.
- 7. Conducts a study that makes it possible to obtain accurate and balanced data; welcomes its decision and, once approved, will work with the relevant parties and monitor its implementation;
- 8. Maintains and analyses the personnel data of public offices; and, when necessary, refer it to the parties concerned;
- 9. decide on requests for authorization of retention of public servants in service beyond retirement age as per the relevant laws and determine measures of executives bureaus and different administrative hierarchies taken against civil servants;
- 10. Undertake study on the different types of allowance, incentives and compensations entitled for civil servants and appointees submit to the Regional Administrative Council; implement same up on approval;
- 11. Maintains and analyses the personnel data of public offices; and, when necessary, refer it to the parties concerned;
- 12. to ensure that the recruitment, placement, promotion, transfer, training and observance of discipline of employees of the State organs civil service are effected in cordance with the law;
- 13. Entertain and render final decisions on appeals submitted to it by the Region's civil servants, due to the infringement of rights, as the result of suspension from duty, rigorous

- disciplinary penalties, unlawful withholding or termination of salary and injuries sustained in relation to work.
- 14. Ensures that the structure at all levels is implemented in the personnel management rules and provides advice and training related to the personnel management rules at the various levels;
- 15. prepares requirements needed educational opportunities, training and exchange of experience required from government employees;
- 16. Issues detailed instructions for evaluating the performance of state government employees, and monitors their implementation;
- 17. Shall make the final decision on the measures taken by the public authorities regarding the recruitment, transfer, promotion, reduction, dismissal and fines in accordance with the applicable labor management laws.
- 18. In collaboration with the relevant authorities, evaluate the structure and operation of the local government staff; submits his / her views on appropriate reforms, and, upon approval, monitors its implementation;
- 19. Study the pay scales for local government employees and monitor their implementation when approved;
- 20. Prepares studies on the various rights and benefits and overnight stays of local staff, submits them to stakeholders, and, upon approval, implements them
- 21. Perform other activities that help to achieve its objectives or carry out its power and duties given by law.
- 22. own and possess property, enter into contracts, sue or be sued in its own name

# Article 21 powers and duties Roads and Transport Bureau

Without prejudice to the provisions of existing other laws, the Roads and Transport Bureau shall, pursuant to this proclamation, have the following powers and duties:-

1. based on policies and strategy set at federal level, Design the Regional state policies and strategy on transport, roads construction and protection of the security of roads of the region, implement upon approval;

- 2. ensure all works to be undertaken in road sector such as roads construction and roads design activities are done in conformity with roads design standards;
- 3. Monitors all road construction and maintenance activities in the area; and conducts research and research into the introduction of technologies, modern equipment used in the construction and maintenance of roads;
- 4. Ensures that road maintenance is provided to the community by providing technical support and coordinating their work;
- 5. Ensure and follow up the efficiency and equitable provisions of transport services are provided to the inhabitants of urban areas and woredas areas and fully cover the transport demand of the public at large;.
- 6. Register public commercial and transport associations, and approves the plan of trips schedules submitted by the associations.
- 7. Organize, register and provide grant license to transport associations established in the Regional state, after ensuring that it comply with the requirement set by law for the formation of associations;
- 8. Implements fines imposed on motorists and drivers who violate the Traffic and Safety Rules in accordance with applicable laws.
- 9. In close collaboration with the Road Safety Department of the Police Commission ensures the enforcement of traffic and safety laws and ensures that drivers who violate it receive appropriate legal action
- 10. Determine the operations, size, and number. of passengers and load of vehicles using the road and approves tariff rate by persons or associations engaged in road transport services.
- 11. Register and issue driving license to persons trained in driving profession after duly subjected an assessment exam to ensure their driving competence;
- 12. Issue certificate of professional efficiency to vehicle maintenance and repair garages established in the region, and to persons and organizations who train motor vehicles driving, and supervise same there of;
- 13. In cooperation with the concerned organs, ensure that traffic control posts and devises in the Region are regularly maintained;

- 14. Ensure and devote on ways installing traffic control devices operating with power light and other relating posts are placed
- 15. construct, maintain and administer the operation of inter- urban vehicles terminals;
- 16. In cooperation with the concerned organs, facilitate and support the construction of air transport, road transport and railway transport undertakings in the Region;
- 17. Ensures that the transportation service is appropriate to the needs of the customers; in the event of a traffic problem or in the event of an emergency requiring additional transportation shall be activated by the individual, company or organization's commercial vehicles:
- 18. The vehicle that conducts the annual inspection of the technical aspects shall provide proof of the quality of the vehicle with the bolts affixed to its windshield;
- 19. Determine the ceiling and initial of service tariff until conducive conditions for effective market competition are created; follow up the implementation of same;
- 20. Perform other activities that help to achieve its objectives or carry out its power and duties given by law.
- 21. own and possess property, enter into contracts, sue or be sued in its own name;

# Article 22:-The powers and duties The Bureau of Security

Without prejudice to the provisions of other laws, The Bureau of Security shall have the following powers and duties:-

- 1. Follow up and ensure the maintenance of law and order in the Regional State and the protection of peace and security of the community thereof;
- 2. Pursue the activities of those individuals, groups and organizations bent on dismantling the constitutional order by force and thereby jeopardize public and Government interests in a clandestine manner, paralyze such activities and provide protection thereof;
- 3. Facilitate conditions whereby misunderstandings arising between and among the communities resident in the zonal, woreda and kebele administrations belonging to the Regional State might be resolved peacefully and amicably;

- 4. by mobilizing the concerned Regional States; ensure favorable conditions for the pacific settlement of conflicts and disputes arising between the Region and its neighboring Regional States;
- 5. Identify the causes of conflicts having been supported by studies, prevent the occurrence of conflicts, strive to resolve same upon its emergence, using traditional and contemporary conflict-resolution mechanisms and carry out the stabilization of ongoing conflicts;
- 6. Observe that the peace and security of the people of the Region is safeguarded through an early prevention of the commission of crimes and encourage the community so that the latter may participate in crime prevention activities and hence forth take care of its own peace and security;
- 7. devote and propose peace full means of conflicts arising between the neighboring Regional States and within the Region and identify factors serving as causes of conflicts among communities; and by collaborating with the concerned parties, works their resolution peacefully;
- 8. Follow up that prisoners are bent in manner they do not disrupt peace and security of the Region and they are properly corrected, and thereby reintegrate themselves into social life and become active after release; ensure that appropriate measures to be taken there to;
- 9. Study the need of the security institutions for the necessary manpower, armament and material facilities with the view to accomplishing their mission and cause its fulfillment thereof as per the studies;
- 10. Having looked into the armament and firearms' purchasing requirements, carry out the procurement and inspection activities in collaboration with the pertinent bodies;
- 11. Supervise, the undertaking activities of arming, licensing and renewing same in respect of those qualifying to carry Guns for self-defense purposes, and ensure that the police Commission has undertaken the arming, licensing and renewing as per the applicable provisions of laws;
- 12. Issue and renew license, revoke and supervise same, in respect of private security guard bodies organized by law;
- 13. Maintain working relationships with the appropriate Federal Government in matters involving conflict prevention and resolution as well as security observance and prevention of organized crimes.

- 14. as per the pertinent government governing directives and applicable laws recruit, organize, train and deploy militia force to be deployed at various levels;
- 15. follow up as to how the police forces and state militia organized in the Region are prepared to prevent and control any criminal acts intended to destabilize the Regional state;
- 16. Collect and analyze criminal data and statistics related with the Regional state's security and stabilities by taking the appropriate measures for the realization of durable solutions;
- 17. appoints high rank police nominees;
- 18. follow up and evaluate the working and operational system of Security agencies at various administrative hierarchy;
- 19. Perform other activities that help to achieve its objectives or carry out its power and duties given by law;
- 20. own and possess property, enter into contracts, sue or be sued in its own name;

## **Article 23:- Power and duties of The Attorney General**

In addition to the powers and duties given to the Bureau by the provisions of other laws: the Attorney General shall have the following powers and duties:.

- 1. prepares criminal justice policy by coordinating relevant bodies; coordinate, follows up and ensures its implementation when adopted;
- 2. works as principal advisor and representative of the regional state government regarding law;
- 3. Organize Public Prosecutors Administration Council that appoints, administers, promote, demote and dismiss public prosecutors that works at various levels of the office.
- 4. save the powers given to the police by other laws, causes criminal investigation to be started on cases falling under the jurisdiction of federal courts, follow up report to be submitted on an ongoing criminal investigation, the investigation to be completed appropriately, orders discontinuation or restart of discontinued investigation on the basis of public interest or when it is clearly known that there could be no criminal liability, ensures that investigation is conducted in accordance with the law, gives the necessary instruction;

- 5. a criminal investigation which has been started by the police needs to be notified to it; makes the necessary follow up in the course of investigation; may seek support from the police in the process of giving decision on an investigation file; informs the relevant police about decisions given on criminal case files by the public prosecutor and court; receives and gives decision on appeals presented by the police against decisions given at different level of the public prosecution;
- 6. reviews completed investigation files based on evidence and law and gives no case or closing decision where condition provided under the criminal procedure law are met;
- 7. determines guilty plea, conducts plea bargaining, decides alternative actions to be taken, follows the implementation;
- 8. Institutes criminal case charges by representing the State government, litigates, and withdraws charge when found necessary in the interest of the public, resumes withdrew charge. However issues directive concerning the withdrawal of cases having national interest with consultation of the chief administrator;
- 9. follows the implementation and enforcement of judgments and orders given by courts under criminal case, applies to the court that gave judgments and orders and makes corrective action to be taken where they have not been implemented or their implementation is contrary to law;
- 10. Organizes or ensures the establishment of systems for the proper execution of criminal punishments imposed by the court of law;
- 11. study the causes of and the methods for prevention of crimes perpetrated in the Regional State;
- 12. pay visit to persons under custody at police stations and correction facilities, ensure their handling and stay is carried out in accordance with the law, cause unlawful act to be corrected; take measures or cause measures to be taken based on the law against people who are found to have transgressed the law;
- 13. Presents death penalty decisions rendered by the state Court to the Federal Attorney General and to the president, follows the execution;
- 14. Litigates, enforces, causes enforcement, follows and controls the process of enforcement within the state government offices by acting as an agent of rights and interest of the public and state government;

- 15. institute civil suits on behalf of the state government office; represent them in civil litigation where they sue or sued, represent them in an ongoing civil litigation by its own or together with them; gives direction to government offices on the management of the litigation; cause execution of judgment in accordance with law;
- 16. Conducts litigation by representing citizens who do not have financial capacity to institute civil action under state courts specially women, children, disabled and the elderly;
- 17. Represent victims of crime who do not have financial means in litigations or negotiations for their compensation, reinstitution and protection of their civil interests emanated from the damage sustained;
- 18. perform preparation of draft laws to be promulgated by the state government; ensure that draft laws prepared by government organs are consistent with the Constitution and other laws; provide legal opinion to concerned bodies;
- 19. advises and participates with concerned bodies in contract preparation and negotiation of mega government projects; participates or advises concerned bodies in other contract preparation and negotiation when it believes that public and government interest could be affected;
- 20. Undertake legal reform studies and carry out codification, compilation and consolidation of laws enacted by the state government;
- 21. ensure the implementation of laws enacted by state government and the consistency of their implementation; and that the offices of executive regional state perform their business in accordance with the law;
- 22. provide or cause to provide, where necessary, training on matters of law, to officials, appointees, elected officials and employees of the federal government and actors of private sector with the view to ensure observance of rule of law;
- 23. Establish, and enforce a system that enables the collection, organization, analysis and dissemination of criminal justice information of the Region;
- 24. Provide training or cause provision of training and education at every level for continuous development of the attitude, knowledge and skill of public prosecutors;
- 25. translate into Somali language federal laws with nationwide scope of application;

- 26. Design strategy for provision of free legal aid, follow up implementation of same, coordinate bodies engaged in the sector;
- 27. based on national human rights action plan prepare statewide human rights action plan together with the concerned bodies, follow up implementation of same, coordinate the concerned bodies at national level; submit report to the relevant bodies;
- 28. Provide, through various means, human rights education and legal awareness training; coordinate the concerned bodies operating in the sectors;
- 29. supervise and administer advocates practicing at Regional level and services provided by them; based on the law, license the same and renew, suspend, or revoke the license granted to them;
- 30. Undertake The Authentication and Registration of Documents and acts entered in the Region and ensure that it comply with the relevant laws.
- 31. register, non-profit making local organizations and associations that operates within Regional state;
- 32. organize inspection department and investigate that decisions passed by public prosecutors are in accordance with the law, identify defects based on studies and take corrective measures on the bases of findings to rectify the problems; when necessary, take measure or cause measures to be taken, based on a law, against those who are found to have breached laws and disciplinary rules, scale up good practices;
- 33. own and possess property, enter into contracts, sue or be sued in its own name;
- 34. Perform other activities that help to achieve its objectives or carry out its power and duties given by law.

## **Article 24:- Powers and Duties of Water Bureau**

Without prejudice to the provisions of existing other laws, the water Bureau shall have the following powers and duties:-

1. Based on water resource management policy and strategy issued by the Federal Governments, Cause the Preparation of state wide water policy and strategy that consider the regional particular circumstances.

- 2. Prepares long-term, medium and short term plans and policies for the expansion of local water resources development activities. Once approved, it will be implemented.
- Implements the General Environmental Laboratory which checks the quality and sanitation of drinking water used in the Environment and ensures that the equipment and professionals required are completed.
- 4. Study the Regional reserves of water resource and its distribution, shall collect and organize data related to water, cause the utilization of the same;
- 5. Conducts studies and designs for drinking water projects; monitors water service related buildings;
- 6. Ensures that water resources are distributed to the environment and used in a balanced and fair manner.
- 7. Identifies the type and grade of water works that require holiday licenses. Individuals or companies engaged in these works shall be licensed for the level and authorization of the work, and shall monitor the smooth running of their work.
- 8. In collaboration with relevant government and non-governmental organizations, enable the community to participate in the construction and maintenance of water facilities;
- 9. Provides training and support to water commissions and relevant community members in order for water facilities to be sustainable;
- 10. To monitor the safety of resources and water companies in collaboration with the relevant users and offices; makes it possible for those in need of repair to be repaired;
- 11. Monitors that water resources are hygienic, monitors contaminants of water resources, studies their sources and makes it possible to eliminate them, with the help of stakeholders. enables legal and technical action;
- 12. Enables the operation of modern technology that is conducive to the growth of water resources;
- 13. Conducts cost-effective tariffs for water service, determines and monitors waste collection and prevention;

- 14. Provides water-related services for laboratory services; and charges a service equivalent to the cost of the service;
- 15. In order to protect and develop water sanitation resources, the relevant members at the federal and local levels will work closely with each other.
- 16. Gathers as needed meteorological data for the development of water resources
- 17. Perform other activities that help to achieve its objectives or carry out its power and duties given by law.
- 18. own and possess property, enter into contracts, sue or be sued in its own name

# Article 25<sup>:-</sup> powers and duties of Technical, Vocational Training and Science

Without prejudice to the provisions of other laws, the Technical, Vocational Training and Science shall have the following powers and duties:-

- based on national strategy and goals on technical and vocational education and training,
   Prepare regional policy and strategies of Technical and Vocational Education and Training implement or cause to be implemented up on approval
- 2. Administer government institutions and centers of Technical, Vocational, Education and Training and science, supervise the provisions of institutions a quality education;
- 3. play a key role so that the technical and vocationaleducation and training in stitutions and colleges in the Regional state may establish experience sharing relationship with other similar institutions and colleges in and outside the country;
- 4. Facilitate conditions through which investors, trade community participate in the development of Technical and Vocational Education and Training colleges in the Region and be benefited from the innovation and skilled force produced by the colleges;
- 5. Ensures that the governing bodies of the colleges are established and fulfils the tasks assigned to them and proposes corrective measures if necessary.
- 6. Oversee the setup the technical and vocational education college's councils and they are discharging their entrusted duties properly, forwards any necessary as corrective measure.

- 7. Upon evaluating the experience and capacity of the deans and deputy deans of technical and vocational education and training colleges and including its comments submit the same to the office of the president for appointment; In situations where, due to lack of efficiency or lack of professional ethics, the dean or the deputy deans should be removed from their position, the Bureau shall submit the same with recommendations to the office of the president.
- 8. In collaboration with relevant stakeholders, cause the technical and vocational education and training and science institutions to make them center providing support to the small scale enterprises and technological and innovational transfer; based on study conducted on the market needs.
- 9. Establish and organize technology and science information management centers.

- 11. Provide recognition license for privately owned technical and vocational education and training colleges; based on the qualification standard regulation, nullify recognition documents of those institutions that are below standard and that have problems on training quality;
- 12. issue directives that regulates the managing and accreditation of public owned the technical and vocational education and training and science institutions, supervise its implementations;
- 13. Establish and follow up professional competency certification system;
- 14. design a system for the participation of private investors, the public, governmental and non-governmental organizations in technical and vocational education and training sector;
- 15. Design special schemes that enables to create an special schemes and all gender related services for women and disabled persons in technical and vocational education and training and science sector:
- 16. Provide the necessary work cooperation upon identifying their gap and in collaboration with the concerned bodies, to the graduates of technical and vocation at the time when they involve into job upon organization in their respective field; follow up that such support is provided;
- 17. Conduct research related to technical and scientific education and support those working in this field.

- 18. Issues and implements instructions for the implementation of homework assignments and procedures in the technical and scientific education system.
- 19. Establish and follow up professional competency certification centers, ensure their activities and programs;
- 20. Cause a tracer study to be undertaken on market demand assessment before training and post training evaluation to be undertaken, cause weaknesses to be corrected based on the result of the examination;
- 21. Based on the development strategy of the regional state set standards required for the region's technical and vocational education and training programs;
- 22. Draw up and implement execution guideline for the organization of primary and medium technical and vocational education and training programs, curriculum and teaching and learning materials;
- 23. Give accreditation to technical and vocational education and training institutions working in the region, Ensure that training programs carried out in compliance with the its standards; and withdraws same when they are found below the standard;
- 24. Establish professional competency certification centers and institutions;
- 25. Creates political thinking towards technical and scientific education. Based on the economic growth of the region, he proposes a decision on the need for reform.
- 26. Ensure that the distribution of technical and vocational education and training institutions and colleges in the Region are balanced;
- 27. Direct and facilitate conditions in which technical and vocational education and training institutions might be center for technological transfer.
- 28. develop a system that enables technical and vocational education and training institutions to undertake training programs to be carried out in a coordinated and partnership manner; provide support and supervision for the implementation of same;
- 29. Cause the preparation of curriculum and control implementation of regular and non-regular (short term) technical and vocational training in conformity with to promote market demands, cause the its implementation;
- 30. Provides office staff and teachers with access to education and training to build their capacity because of market demand.

- 31. It sets the direction for the development of revenue sources for colleges so that it can cover its future expenses.
- 32. In accordance with the applicable Financial Management Regulations, Determines the amount of fees to be paid to professionals taking the standardized proficiency test.
- 33. In order to have an education system that is in line with the country's education system, it must cooperate with the partner offices on a regular basis.
- 34. Perform other activities that help to achieve its objectives or carry out its power and duties given by law.
- 35. own and possess property, enter into contracts, sue or be sued in its own name

#### Article 26; Powers and Duties of Labour and Social Affairs Bureau

In addition to the powers and duties given to the Bureau by the provisions of other laws: the Labour and Social Affairs Bureau shall have the following powers and duties to:.

- 1. prepare and implement Regional laws and policies relating to labor;
- 2. with a view to ensuring the maintenance of industrial peace encourage and support workers and employers to exercise their rights to organize and collective bargaining;
- 3. Set a mechanism to amicably settle labor disputes arising between employers and employees;
- 4. issue occupational health and safety standards of empolyers and supervise their implementation;
- 5. Encourage and support employers and workers to form organizations and thereby exercise their rights of collective bargaining;
- 6. Undertake studies on, unemployed manpower and occupational classifications in the Region; collect, compile and disseminate information on labor market of employee and employer, occupational safety ,and study and annualize the availability of different job opportunity in the Region then submits the information to the legislative body and other organs that require it for policy purposes;
- 7. collect, compile and disseminate information on manpower and employment, safety and health of workers and on other matters relating to labour relations; undertake studies on the prevention of social problems; coordinate and give assistance to the appropriateorgans in eliminatingsocialproblems;

- 8. Shall study on the challenges of employment in the job seeking process and the working environment of the Region.
- 9. Shall follow up the employment procedures of enterprises and organizations in the Region;
- 10. Register employers' association and trade unions established at Regional level;
- 11. Ensure that foreign nationals working the Region have a renewed work permits to operate in the Region, supervise the compliance therewith;
- 12. register trade unions and collective agreements relating to regional state Public Enterprises, carry out labor inspection services in such enterprises; provide conciliation services to Set a mechanism to amicably settle labor disputes arising between employers and employees.
- 13. in collaboration with the concerned bodies carry out studies to improve the social protection system, in particular to programs that Enable the elderly and people with disabilities benefit from equal opportunities and full participation;
- 14. enable the elderly to get care and support and enhance their participation;
- 15. Design and execute projects and programs aimed the prevention of social problems and provision of rehabilitation services to the affected members of the society.
- 16. Undertake studies on ways of protection and mechanism on prevention of causes of dissolution of family as Family is the fundamental unit of society and forwards the appropriate suggestions.
- 17. Undertake awareness creation forums, seminars and trainings necessary for disseminating the importance of family unit and for the prevention of any matter that may adversely affect.
- 18. implement the direct support projects of productive safetynet program provided to people who cannot work;
- 19. in cooperation with the concerned Bureaus, works the prevention and deterrence of illegal human trafficking;
- 20. Perform other activities that help to achieve its objectives or carry out its power and duties given by law.
- 21. own and possess property, enter into contracts, sue or be sued in its own name;

#### Article 27 Powers and Duties of women's and children affairs Bureau

In addition to the powers and duties given to the Bureau by the provisions of other laws: the women's and children affairs Bureau shall have the following powers and duties:.

- based on the national policy and strategy on women's and children rights Design regional
  policy and strategy to ensure the protection of women and children rights and implement
  same:
- 2. ensure that opportunities are created for women and youth to actively participate in political, economic and social affairs of the Region and implement same;
- 3. Encourage and support women and youth to be organized, based on their interests and needs, with a view to defending their rights and solving their problems;
- 4. Design strategies to follow up and regulate that the preparation of policies, legislations, development programs and projects by State Government organs give due considerations to the issues of women and children;
- 5. Undertake studies to identify discriminatory practices affecting women, facilitate the creation of conditions for the elimination of such practices, and follow up their implementation;
- 6. Ensure that due attention is given to assign women for decision-making positions in various Government organs;
- 7. build working relationship between governmental and non-governmental organs working on development and care taking of women and children, ensures whether implemented in coordinated manner;
- 8. ensure the proper implementation in The Region of the rights of women and children granted under the international treaties ratified by Ethiopia and under the constitution;
- 9. design and implement programs aimed to promote the care and well-being of women's and children in the Region;
- 10. Facilitate the setting up programs and projects that generate development funds to create job opportunities for and enhancing of women's and children live hood.
- 11. design and present to the State Cabinet Council, action-plans relating the development of women's and children in the Region, implements upon approval;
- 12. Ensures gender equality in area of employment, education and social services.

- 13. fellow up the implementation of programs on the well-being and care of women's and children being carried out different organization and institutions in the Region;
- 14. in collaboration with the relevant regional government organs works to providing alternative financial sources in the form of loans and donations to women's and Children cooperatives to improve their livelihoods and alleviate poverty;
- 15. cause to be provided care, assistance and good parenting services to neglected children and those without the care of his or her parents;
- 16. So as to promote the participation of children organize and build the capacity of child parliaments.
- 17. facilitate the setting up centers for provision of holistic health, psychological, legal and rehabilitation services for women who were victims of violence; and follow up the implementation of same;
- 18. Coordinate that women and children are beneficiaries of Services provided by all stakeholders;
- 19. undertake studies and researches aimed to identify problems associated with the women's and children as well as problems that encountered in the implementation of provisions of women's and children rights particularly in Political, economic and Social endeavors;
- 20. Establish a system to prevent and response to neglect, manipulation and expropriations of children.
- 21. Perform other activities that help to achieve its objectives or carry out its power and duties given by law.
- 22. own and possess property, enter into contracts, sue or be sued in its own name;

#### Article 28. Powers and duties of Culture and Tourism Bureau

Without prejudice to the provisions to other laws, the Regional Bureau of Culture and Tourism shall have the following powers and duties:

- 1. Initate policy and strategies for the development of culture of the regional state, execute upon approval.
- 2. Give support for the proper preservation of cultural heritage which are in the possession of any person, association or religious organization or organs of the Region.

- 3. Cause the registration and maintenance of history and culture of the Somali people of the Region.
- 4. Cause the implementation of policies towards tourism and culture in the Region.
- Cause the expansion of public libraries, archives and museum and support those already established.
- 6. Cause the study of dialectic languages spoken in the region to make it the language of education and work and promote the development and expansion of their literature.
- 7. Facilitate conditions, in cooperation with the concerned organs of the regional state for the procurement of art equipment and materials.
- 8. work on the promotion of creativity of film industry and theatrical arts;
- 9. to cause following directs issued by the federal ministry of Tourism and Culture, on the discovery, protection study maintenance and utilization of historical heritage and register with detail descriptions of antiquities and cultures in the process of extinction.
- 10. Establish Regional council of Culture.
- 11. To encourage and support the development of tourist facilities of the Region based on the country's tourism policies.
- 12. Supervise the tourism institution's basic commodities and services in the Region.
- 13. Gives license and supervise domestic investors involved in the tourism sector of the Region.
- 14. Undertaking studies relating to Regional tourism, compiles and disseminate information to the concerned bodies;
- 15. Shall register the regional tourism attractions, organize, extend and protect it.
- 16. Undertake grading and categorizing of hotels and other facilities engaged in Tourism provisions.
- 17. Collect and compile different documents, handicraft, films and documented information's on culture that is useful for the attraction of tourism, and cause the participation of private sector in tourism sector
- 18. Promote creativity in handicraft, artistic works and fine art; create conducive environment for the development of the Somali cultural identity;
- 19. work in the advancement study and promotion of the Somali language in the Region;

- 20. establish, support and cause the creation of special revenue generating source for the artisans and literature club of the Region;
- 21. Coordinate concerned organs of the Regional administration and non-governmental organizations on the tourism sector
- 22. Own property, enter into contracts sue and sued in its own names.

#### Article 29:- powers and duties of the Disaster Risk Management Bureau

Without prejudice with the provisions of other laws, the Disaster Risk Management Bureau shall have the following powers and duties:-

- 1. Prepare a long term, medium and short term Regional natural disaster. Prevention and preparedness policy and strategic plan for improvement of its application;
- 2. Direct and coordinate all non-governmental organizations and governmental organs working in the disaster. Prevention and preparedness activities;
- 3. Establish and formulate mechanism and local strategies for future disaster prevention and preparedness; supervise its implementation upon approval;
- 4. formulate strategies for future disaster prevention by way of studying previous disaster areas;
- 5. in cooperation with the concerned organs, to undertake prior studies on the causes of disaster; setup systems for advance warning;
- 6. in cooperation with the concerned organs, to make known the magnitude and extent of a disaster together with measures that should be taken in connection therewith; officially declare any relevant part of the State a disaster area;
- 7. in accordance with directives issued to it by the government, request for and receive any form of assistance from federal government, domestic sources and non-governmental organizations operating in the Regional state;
- 8. to register all forms of assistance received from domestic and foreign sources and cause the distribution of same to the People being helped;

- 9. evaluate and monitor disaster response programs, and supervise projects implemented by non-governmental aid organizations; forwards the appropriate measure necessary for improvement of any irregularities;
- 10. To inform the public through the mass media of the type, volume and utilization of assistance received from domestic and foreign sources;
- 11. in cooperation with the appropriate organs, to rehabilitate victims of disaster;
- 12. License, organize and supervise the activities of humanitarian and development organizations and donor organizations, report on their performance;
- 13. Prepares rules and regulations related with the supervision and mobilization of local organizations willing to work and participate in the development activities and poverty eradication programs.
- 14. Cause enabling conditions in the Regional state so as to achieve food sufficiency program, facilitate conditions in which relief and supports to be distributed to the community implemented as food for work programs;
- 15. Carry out such other activities necessary for the attainment of its objectives.
- 16. Organize information's related with the number of family affected by the disaster in the Region in need of relief annually and areas of relevant parts in the Regional state.
- 17. collaborate with concerned federal institutions in the collection of data related with the meteorological services use full for the preparedness of natural disasters, provide the necessary support required to the expansion of early warning system to be implemented in the Regional state;
- 18. To carry out such other activities as would enhance the attainment of its objectives.
- 19. own and possess property, enter into contracts, sue or be sued in its own name;

#### Article 30 Powers and duties of The Trade and Industry Bureau

In addition to the powers and duties given to the Bureau by the provisions of other laws: the Trade and Industry Bureau shall have the following powers and duties:?

1. Design and implement upon approval strategies and directives governing the development of trade, and industry of the region

- 2. Register public enterprises established for generating of profits.
- 3. In accordance with laws that are applicable on commercial registration, Establish and Administer regional commercial register.
- 4. Organize national and international exhibitions to be conducted within the region and encourage and publicize the production of system of the region by encouraging the marketing system of livestock and agricultural products.
- 5. By using high standard technology, issue license to persons engaged in various types of commerce, transport services and industrial sector and supervise evaluate and support as well as may revoke the license.
- 6. Provide to the trader and industrial producers in the Region, the necessary support that enables to be competitive in national and international market.
- 7. Register and provide support to the chambers of commerce and cooperatives societies, organized in the region.
- 8. In collaboration with the concerned federal ministries, shall work on ways of strengthen and promoting lawful trade practices of people living in border areas of the Region.
- 9. By preventing and combating inflation of goods, shall ensure that Basic commodities and Goods related to the daily need of consumers, are supplied and distributed on time throughout the region and distributed/sold as per the price fixed by the appropriate organ.
- 10. Carry out procedures of privatizing and transfer public enterprises to individual traders and private investors.
- 11. encourage ways of forming public and private Concession of co-financing mega commercial projects and setting up of appropriate production industries;
- 12. Encourage and provide the necessary support to the cooperatives engaged in Commercial Activity within the regional state.
- 13. Initiate industrial project proposals and transfer of trade and federal and regional government concerned bureau.
- 14. promote the expansion and development of industrial and trade investment aimed for manufacturing of goods for export;

- 15. In cooperation with the concerned organs, cause the establishment of Industrial Zones in urban centers of the Region and cause that provisions of basic infrastructures facilities are constructed,
- 16. encourage that traders engaged in commercial sector of provisions of service agricultural and livestock sector whereby to invest in production industry;
- 17. Provide the necessary support related with selection and utilization of appropriate technologies and the development of professions that contribute to the enhancement of industrial development in region.
- 18. Provide training to build the profession and researches capacity programs so as to protect market competition and quality of industrial products, trade and transport services in the Region. And fellow up its implementation upon approval.
- 19. Undertakes research by studying the demand for trained manpower required to speed up the development of the Industries in the Region and shall make available of the appropriate trained manpower required for the industrial development in collaboration with higher learning institutions;
- 20. ensure the establishment of a system to make cause the availability of raw material in terms of quality and quantity required for the Industries in the Region;
- 21. by establishing relationship with the Regional state and national financial institutions encourage and promote investment of project proposals on industrial development and build the human resource and vocation required by the for Industries in the Region.
- 22. establish coordinated working relationship among small-Scale Industries', medium- Scale Industries and mega Scale Industries in the Region and provide the necessary support so that enables small-Scale Industries transformed to medium- Scale Industries and medium- Scale Industries also transformed to mega Scale Industries;
- 23. Organize the regional industrial data register, whereby the type, location and full data associated with industrial resources of the region are maintained.
- 24. Perform other activities that help to achieve its objectives or carry out its power and duties given by law.
- 25. own and possess property, enter into contracts, sue or be sued in its own name;

#### **Article 31 powers and duties of the Revenue Bureau**

Without prejudice with the provisions of other laws, the Revenue Bureau shall have the following powers and duties:-

- 1. Establish and cause the proper execution and enforcement of tax related laws and rules within the Regional State.
- 2. For the enforcement of Revenue and tax laws, Inspect, audit and examine all sources that are under the obligation to pay tax;
- 3. Determine, collect and administer revenue decided to be collected by the region's government; shared revenue of state government and federal government and revenues delegated by federal government to the state government;
- 4. Undertake various study towards the commercial operation, to expand source of revenue of the Region,
- 5. direct and organize tax reform programs that are underway in the Regional state;
- 6. inspect documents under the possession of any person that are required for the enforcement of tax laws;
- 7. Develop and implement awareness creation programs to promote a culture of voluntary compliance of taxpayers in the discharge of their tax obligations as well as rights, organize a training center wherein to build employees' capacity; and design appropriate training schemes;
- 8. Establish and implement modern revenue assessment and collection system; based on rules of transparency and accountability, efficient, equitable and quality service within the sector as well as ensure proper discharge of tax related obligations.
- 9. Without prejudice with the provisions of other applicable laws, assess, collects and provide technical support to the collection of Revenue of urban services;
- 10. Without prejudice with the provisions of directives to be issued, shall assess, collect and provide technical support in the collection of municipal services Revenue;
- 11. collect and analyze information necessary for the assessment and determination of taxes as well as its collection;

- 12. In collaboration with concerned body, Conduct study and research activities aimed any improvement to be made against the Tax laws of the regional state, cause to be submitted to the Executive cabinet, and implement the same up an approval.
- 13. For improving the efficiency of services delivery to the business community or taxpayers establish centers for accelerating the payment of tax;
- 14. design policies and mechanisms necessary to enhance the growth of Regional State revenue;
- 15. Ensure the proper enforcement of tax laws and that it's collected and administered in a manner conforming to law.
- 16. Perform other activities that help to achieve its objectives.
- 17. own and possess property, enter into contracts, sue or be sued in its own name;

## Article 32: Duties and Responsibilities of Investment and Diaspora affairs bureau

In addition to the powers vested in it by other laws, the Office of Investment and Diaspora shall have the following duties and responsibilities.

- 1. Coordinates and directs all matters relating to the Diaspora.
- 2. shall provide in writing and video to the Diaspora all the information related to the development and good governance of the region.
- 3. The Office in conjunction with the Licensing Offices facilitates the Diaspora's access to emergency services.
- 4. By liaising with the relevant offices, it will make it easier for the Diaspora in the region to obtain the "Identity Card of the Diaspora.
- 5. Study the major challenges and challenges faced by the Diaspora Environmental Investment activities.
- 6. Advises the President on Diaspora Affairs.
- 7. Carries out Mobilization and Awareness activities to prevent the spread of negative ideologies against peace, development and good governance in the Diaspora.
- 8. To develop and establish local and international organizations that are at the forefront of the Diaspora Awareness and Awareness Activities.

- 9. By liaising with the relevant offices, it will facilitate the preparation of land and other resources for the local Diaspora.
- 10. Develop plans and opportunities for local Diaspora to contribute to environmental development and security and attract international investors.
- 11. Upon submission of an application for funding, he shall grant leave, renewal or termination in accordance with the law if he deems it to be a violation of the law.
- 12. It expands and encourages investment activities within the environment.
- 13. Creates environment conditions to create funding for directives and actions to be implemented by submitting them to the executive.
- 14. Collects data, resources and investment opportunities and presents and prepares investment projects
- 15. Prepares and studies various projects, implements and advises investors and monitors their implementation.'
- 16. Creates relationships and partnerships between landlords, government members and other members affected by investment growth.
- 17. Conducts demonstrations, trainings and workshops to encourage local investment.
- 18. Prepares, implements, transcripts and films used for fundraising
- 19. Follows up on investment licensing projects and ensures that the rights and obligations of this declaration are vested in the protected investor.
- 20. Pursuant to investors' terms, conditions and various local regulations
- 21. The certificate, after examining the applications of the investors who started the production, intends to make a decision on the income tax deduction and informs the relevant Somali local government offices to encourage investors.
- 22. Informs the Local Government Executive and the Investment Commission that the implementation of the local investment incentives and third party agreements will be implemented.
- 23. Submits information on local investment activities to the funding board and other relevant members.
- 24. The value when the request for funding has been submitted to the rural hordhigaysaa investment committee to reach a decision looga.
- 25. Carried out other activities to encourage investment activities

- 26. Carries out other activities to encourage investment activities
- 27. Determines how long the investor will be exempt from renting land based on the importance of the project to the community.
- 28. Organizes local-born expatriates to invest in their homeland.
- 29. Liaise with the local diaspora and inform them of the state of the environment so that they can play their part in the development of the local community.
- 30. Performs such other functions as may be permitted by law.
- 31. It may own property and enter into agreements. He can be sued and he can sue.

## Article 33:- The Powers and Duties of the Youth and sport Bureau

Inaddition to The powers and duties given to the Bureau by the provisions of other laws: the Bureau shall have the following powers and duties:.

- 1. Enforce in the region the national youth policy, and pursuant with this; shall prepare the region's Youth policy, and laws;
- 2. Establish region wide youth and sport federations and provide the necessary support.
- 3. Device enabling condition to produce a responsible Youth force and healthy force in the Region and Cause favorable conditions.
- 4. Provide universal support to the Region's youth so that they would organize themselves with their free will, and thereby participate with full capacity in the building up of the Democratic order according pursuant to the of the constitutional terms and principles.
- 5. Promote the expansion of sports facilities and centers in the Region and ensuring determination of the standards of sports associations as
- 6. cause and support the conduct of defferent sports competitions in the Region and ensure the proper organization of the competitions;
- 7. facilitate on ways how the busseness community in the Regional state Encourages sport clubs organized in within the Region as well as to organize the sport clubs in a manner of self dependency and with long tenure of service;
- 8. encourage youth of the Regional State to know the culture and history of the nationnationalities and peoples inhabiting the Region and the country at large

- 9. Promote the expansion, popularization and improvement of trainings and physical exercise of sports in the region.
- 10. Issue business licenses to sports associations to be organized in the region and coordinates and supervise their programs
- 11. Organize regional sport competitions and issue permit regarding the same.
- 12. Settle disputes among sport associations relating to regional sports competitions.
- 13. Facilitate the supply of adequate sports wear and equipment in cooperation with the concerned organs;
- 14. Audits the books of accounts of regional sports associations with a view to ascertaining that their income is utilized only for the fulfillment of their objectives.
- 15. to establish sport centers for conduct of regional sport competitions and support the expansion of sports facilities and centers;
- 16. In cooperation With the regional health bureau organize the production of sports equipment and sports medical facilities;
- 17. design strategies to follow up and evaluate the preparation of policies, legislations, development programs and projects by Government organs to ensure that they give due considerations to issues of the youth;
- 18. Follow up the undertakings of non-governmental organizations working in youth sector and social affairs, reviews, approve and sign with the development projects submitted by them
- 19. encourage and organize, mobilize the youth to own skill of creating works, coordinate and facilitate on conditions how the youths get different training service that might help to engage in different area of interest, on how they get loan, material, work centers as well as all the provisions of necessary supports; and after they transform themselves into labor phase seek remedies for any problems they may encounter.
- 20. Develop and implement strategies that enable to produce a responsible and healthy Youth force.

- 21. Provide the necessary support and followup whether the governmental and non-governmental organizations at various hirarches have properly implemented the national polices and directives on youth sector.
- 22. Mobilize the Regional state youth in accordance with the principles of state Constitution, to discharge their role towards political, economic, social affairs development and promotion of their culture. And thereby actively participate in the building up of the Democratic order, and good governance efforts; establish in a manner that leads to success;
- 23. Devise a system enabling the youth of the Regional State to know the culture and history of their own and nationality, mobilize the strengthen of the regional culture and execute any activities that builds the wellbeing of the Youth.
- 20. Conduct studies and research aimed at youth; distributes the results to the stakeholders;
- 21. Establish sport development fund so as to resolve problems in the sport sector. Details on the implementation of this duty shall be determined by a directive to be issued.
- 22. follow up the activities of different organizations working in the Youth sector, coordinate and monitor their performance and take appropriate correctives measure;
- 23. carry out other activities given by law to achieve its objectives;
- 24. own property, enter into contracts, sue and be sued in its own name;

#### **Article 34 Powers and Duties of Information Bureau**

In addition to the powers and duties given to the Bureau by the provisions of other laws: the Information Bureau shall have the following powers and duties:.

- 1. Leads the mass-media programs and public relation system of the regional government.
- 2. guide Government communication activities and put in place a system by which good performance may be registered in the field;
- 3. Set and coordinate the public relations' activity directions in which the regional government offices are guided;
- 4. Undertake capacity-building activities with regard to the public relations' employees serving the Regional Government Offices;

- 5. Serve in the capacity of the Regional Governments' Spokesperson, serve as the principal source of information, disseminate governmental messages and officiate to the public the position of the Government on the regional and national security affairs;
- 6. Integrate the content and implementation of the communication programs belonging to the regional government;

- 13. Undertake Governmental internet activities and provide with the web-site services and electronic satellite;
- 14. Provide consultancy services in respect of various print, audio-visual recording and publication design works upon request;
- 15. Release periodic statements to the Regional, National and foreign journalists, follow up and provide support to the Federal and overseas news agencies staying in the Region for official duties on temporary or permanent basis

- 16. Issue certificates of registration with regard to the press advertisement and print products to be published for business purpose and whose distribution is limited in the Region and thereby ascertain the legality of their operations;
- 17. Collect, in accordance with law, charges for the services it provides, as deemed necessary.
- 18. Provide ample information to the outside world as regards the Regional state with a view to promoting its positive image as well as defend and withstand the flow of false information so propagated against same;
- 19. Dispatch to the public at large decisions and press conferences circulated by the regional government
- 20. collect and annualize public opinions and thereby transmit same to the bodies concerned;
- 21. Design various printed and audio-visual publications designed to with a view to promoting the positive image the Regional State.;
- 22. Carry out studies on the information and communication programs broadcasted by various media agents operating within the Regional State.

Without prejudice to the existing provisions of other laws, the Environmental protection, Forest and climate change Bureau:

- 1. Based on federal Environmental protection and climate change policies and strategies shall prepare statewide Environmental protection and climate change policies and strategies. And implement upon approval.
- 2. Coordinate measure to ensure that the environmental basic principles and objectives provided under the FDRE and state Constitutions are realized;

- 9. may delegate part of his powers and duties to the other officials and employees of the bureau;

10. Performs other duties assigned to him by the executive organ and the president Of the Regional state.

## ' Article 40:- Powers and Duties of the Deputies of Bureau head

The Deputies of Bureau head;

- 1. in absence of the bureau head shall represent and perform the duties of the bureau head;
- 2. shall perform specific duties given to them by the Bureau head;
- 3. the deputy Bureau shall be accountable to the bureau head;

- M. The Technical and Vocational Education and Training bureau establishment proclamation no: 85/2003.
- 2. No laws or practices shall, in so far as they are inconsistent with this Proclamation, have force or effect with respect to matters provided for by this Proclamation. .

## **Article 47 Power to Issue regulations**

The state cabinet council may issue regulations necessary for the implementation of this Proclamation.

#### **Article 48. Effective Date**

This Proclamation shall enter into force upon its approval by the state council.
